## TUITION ASSISTANCE PROGRAM – 2026/27

As an alternative to the discounts offered through the Tuition Grid, OJCS continues to offer a confidential Tuition Assistance Program to provide reduced tuition to eligible families.

The process for requesting tuition assistance is electronic and applications can be completed through [Apple Financial Services](#), an organization that has been providing financial assistance analysis to private schools in Canada since 1993.

Applications for tuition assistance can be completed at [www.applefinancialservices.ca](http://www.applefinancialservices.ca). Instructions can be found on the website and in the attached FAQ.

The fee for applying through Apple Financial is \$137.50. Under specific circumstances, this fee can be waived at the discretion of the Head of School.

Completed applications must be submitted to Apple Financial by **March 2, 2026**. All applications and the necessary supporting information must be submitted by this deadline for Apple Financial to complete their financial analysis. This is used by the Tuition Assistance Committee when they meet in early April 2026 to make their recommendations. Should an application not be completed by the deadline, there is the potential that it will not be included in the allocation of the available tuition assistance funding by the Tuition Assistance Committee.

Your child(ren) must be registered with the school for the 2026/27 school year prior to your Tuition Assistance Application being accepted for consideration and any outstanding account balances must be paid before Tuition Assistance can be approved.

Once the applications are completed and processed, Apple Financial provides a recommendation to the school's confidential Tuition Assistance Committee. This recommendation is reviewed by the Tuition Assistance Committee, which does not include OJCS parents, staff, teachers, or board members. Committee Members must agree to a confidentiality agreement. Tuition assistance information is not shared with teachers or the Board of Directors.

## **Frequently Asked Questions (FAQ)**

### **1. What is Apple Financial Services?**

(From their website)

Apple Financial Services has been providing bursary and financial assistance analysis to private schools in Canada since 1993. The analysis service provides an arm's length evaluation of financial aid applications and provides an unbiased evaluation of the applicant's financial resources and ability to fund their private education.

Currently, we provide this service to the families that are applying to or in attendance at over 180 schools across Canada.

We are an organization managed by professionals having legal and accounting degrees accredited in Canada, and with people having accounting, financial and tax experience in Canada and the United States.

Our goals are:

1. To provide quick, insightful, unbiased evaluations of the financial resources available to applicants
2. To act as a financial assistance advisor and consultant to the finance and admissions departments of private schools, to help them effectively manage and continually improve their application process.

### **3. How do I apply?**

**Step 1.** From the homepage of the website ([www.applefinancialservices.ca](http://www.applefinancialservices.ca)), select "Register Now" and enter your information to create an account.

**Step 2.** A confirmation email will be sent to the address used to create the account. Verify that you received the email by clicking on the link and you will be able to log into your account.

**Step 3.** Login to your account and select "My Application". The privacy policy and terms of service will appear, please review them and select "I Agree" to move forward. Then work through the six sections by answering all the questions and entering in your financial information. Please note that this may take several hours depending on the complexity of your financial situation.

**Step 4.** Once you have entered all the information on your application and have reviewed it for errors, press "Next" on the "Dependent Information" tab to move to the document upload screen. If you do not

have a scanner/camera, or do not have all the documents with you at this time, you may select "Mail/Fax documents later" in order to proceed. Please note that Apple Financial will be unable to process your application until they receive the requested documents and have uploaded them into your file online.

- After the application is completed, if you need to provide further documentation, it may be mailed, emailed, faxed, or uploaded using the "Upload Additional Documents" link.

**Step 5.** After the documents are uploaded/will be sent later, press "Submit" to be taken to the payment screen. Once your payment is processed, you will be sent a confirmation email.

#### **4. Is there a fee for applying?**

There is a fee of \$137.50 per application to be paid at the time of submission of the application. Based on specific circumstances, the Head of School can waive this fee.

#### **5. Where can I learn more about Apple Financial Services and the application process?**

#### **6. Is Apple Financial making the decisions on how much assistance I will receive?**

No. Apple Financial is simply processing the applications and making a recommendation, based on many different factors, such as cash flow, net income, number of children, etc. The Tuition Assistance Committee will use this information to determine the amount of tuition assistance on a case-by-case basis.

#### **7. When will the Tuition Assistance Committee render their decision?**

The Tuition Assistance Committee will review all applications received before the deadline of March 2, 2026 and will endeavour to communicate their decision to applicants by the end of May 2026. Please note that this date may change depending on the number of applications received, as the Committee reviews applications in batches at each meeting and the review process may stretch over a number of meetings. Please also note that decisions will be communicated to applicants once all the applications received before the deadline have been processed.

#### **8. What if I don't agree with the tuition assistance amount given?**

An appeal can be made to the Tuition Assistance Committee in writing by providing a letter in a sealed envelope clearly marked to "Head of School", **WITHIN 7 DAYS OF RECEIPT OF ORIGINAL DECISION**. You will be asked to provide a revised request for tuition assistance with any additional information, narrative, context, or circumstances that were not previously considered in the original application.

**9. What happens after I submit an appeal and provide the additional information that was requested?**

The Tuition Assistance Committee will consider the revised request, the additional information provided, the initial Apple recommendation, and will consult with the Finance Committee on the tuition assistance budget to determine the revised tuition assistance decision. Any information shared with the Finance Committee will be anonymized to ensure the confidentiality and integrity of the process. The appeal decision will be communicated to the parents and is final; there are no further appeals.

**10. What if I submit my application to Apple Financial after the deadline?**

The Tuition Assistance Committee considers applications received before the deadline first. Every year the Board of Directors allocates a portion of the school's budget towards tuition subsidies. If your application is late and the tuition subsidy budget has been exhausted, it may not be possible to award your requested subsidy amount.

**11. What if I can't meet the application deadline?**

If you are unable to meet the application deadline due to extenuating circumstances, please contact the Head of School at (613) 722-0020. Ext. 333 to discuss options.
